1. **Identification Check** – required to confirm identity

100 points required, including photo ID. Suitable identification may include:

Telephone, Electricity, Gas Account	10 points

Council / Water Rates Notice	10 points

2. **Income Check** – required to confirm ability to afford rent

Provide (where applicable): current employment payslips (last two), bank statement (showing income credits), or Centrelink statement. If self-employed you may wish to provide recent tax return or accountant details / contact information.

- 3. <u>Current + Previous Rental History</u> required to confirm suitability as tenant
 Provide address of rented premises and full name / contact details of agents /
 owners. Current or previous home owners who have sold a property, may wish to
 provide contact details of agent who sold the home. Application can be
 strengthened by providing a copy of tenancy ledger.
- 4. <u>Employment Reference</u> required to confirm accuracy of payslips / ability to pay rent Provide employer contact details (where applicable).
- 5. **Personal Reference** required to confirm suitability as tenant

Provide name and current telephone number of anyone who has known you in the past three years, but is not related to you. E.g. employer, work colleague, neighbour, previous real estate agent, family friend, etc. Application can be strengthened by providing us with references who can provide details on how you care for a property.
